

# Thompsonized® Wood Limited Warranty

Lifetime limited warranty certificate covering your use of Thompsonized® Wood for as long as you own your home

Your Thompsonized® Wood has been pressure treated with an effective wood preservative and when used to construct a single family residential decking structure is warranted against any damage by termites or fungal decay that would make the lumber structurally unfit for the application for which it was intended.

This warranty is good from the date of purchase for as long as you own the property on which your new Thompsonized residential decking structures are built. This warranty is not transferable. The original consumer purchaser will be entitled to receive new Thompsonized® Wood in exchange for wood damaged by termites or fungal decay, or no longer meets the industry specifications for water repellency per AWP A E13-92. To make arrangements for this exchange of wood, the original owner must send one of the warranty labels, along with the original purchase invoice, showing the date of purchase and showing that sufficient Thompsonized® Wood has been purchased to cover the number of board feet claimed to be

damaged, to warrantor, the licensor of the Thompsonized trademark, at:

When making any warranty claim you may be required to send photographs® and pieces of damaged wood. In addition, at the warrantor's request, the warrantor and its representatives and agents must be permitted to inspect and test the damaged decking structure.

The warrantor shall not be liable hereunder for damage to Thompsonized® Wood for any application other than single family residential decking, or for damage resulting from any cause other than termites or fungal decay or loss of water repellency efficacy below the standards set forth in AWP A E13-92.

This warranty shall extend only to Thompsonized® Wood which is manufactured from Southern Yellow Pine. This warranty does not cover Thompsonized® Redwood or any Thompsonized® Wood Specialty Deck Product.

The warrantor shall not be liable for any installation or reinstallation costs, or for the natural characteristic of some wood to check, split, warp, twist, or suffer other dimensional changes, or for any incidental or consequential damages. The warrantor shall have no further liabilities or obligations hereunder, except as expressly stated herein. Nothing in this limited warranty is intended to or shall change duration of any implied warranties, or shall give the purchaser any implied warranties he would not otherwise have, extend the same beyond their customary duration, or make the warrantor liable for any implied warranties that it would not be liable for if this limited warranty had not been given.

This warranty shall apply only to product that is purchased and installed within the United States. Some states do not allow limitations on how long any implied warranty lasts and/or the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. The warranty gives you specific legal rights, and you may also have other rights which vary from state to state.
